

# WHOLESALE & RETAILER ACKNOWLEDGEMENT GUIDELINES

(For transactions from 1<sup>st</sup> Nov-2012 to September-2017)

**The unlocking is effective from 16<sup>th</sup> September 2017 to 25<sup>th</sup> September 2017.**

## Retailer Pending Acknowledgements

### **1. Pilot Districts on GO Live:**

**Retailer Acknowledgements pending for the period prior to Go Live date:**

- Acknowledgement to be done through Web/mobile. The stock so acknowledged not to be added to the retailer stock.

**Retailer Acknowledgements pending for the period after Go Live date up to September'2017**

- Stock to be acknowledged by the retailer through PoS only. The stock so acknowledged to be added to the current stock of the retailer on the current date.

### **2. States and Districts on Dry Run:**

Definition of Dry Run States or Districts: These are the states/districts where PoS deployment has been completed. i.e.,

- PoS is installed at retail point,
- Retailer is registered on PoS with the mFMS ID.
- Initial stock is entered in PoS. This is called stock initialization.
- Retailer is doing fertilizer sales through PoS.

**Acknowledgements pending prior to stock initialization:**

- Acknowledgement to be done through Web/mobile. The stock so acknowledged not to be added to the retailer stock.

**Acknowledgements pending after the date of stock initialization:**

- **Stock to be acknowledged by the retailer through Web/mobile.** The stock so acknowledged to be added to the current stock of the retailer on current date (i.e., server date). **The acknowledged stock will be reflected in PoS on next day of acknowledgement.**

### **3. States/Districts where deployment is ongoing:**

**Acknowledgements pending prior to stock initialization:**

- Acknowledgement will be done through Web/mobile. The stock so acknowledged will not be added to the retailer stock.

**Acknowledgements pending after the date of stock initialization:**

- **Stock to be acknowledged by the retailer through Web/mobile.** The stock so acknowledged to be added to the stock of the retailer on the current date (i.e.,

server date). The acknowledged stock will be reflected in PoS on next day of acknowledgement.

### **Wholesaler Pending Acknowledgements & Dispatch/Sales**

- Wholesaler locked transaction will be available for acknowledgements through web from the period dated, 1<sup>st</sup> Nov. 2012 – September-2017.
- The dispatch/sale from wholesaler to retailers would also be allowed for the past dated invoices i.e. with invoice dated from 1st Nov-2012 to September-2017 using the older iFMS upload functionality.

#### **NOTE:**

**The reversal of desptach/sale transaction from any point to wholesaler & retailer will not be allowed during this period.**
